About RRU

UZH University of Zurich

The University of Zurich (UZH) is Switzerland's largest university and a powerhouse of European research. Founded in 1833, it holds the distinction of being the first university in Europe established by a democratic state rather than by a monarch or the church. Today, UZH is a comprehensive university with over 28,000 students and a reputation for excellence across a vast range of disciplines, particularly in Medicine, Economics, and the Life Sciences.

WHY SWISS ?

Switzerland's specialization in blockchain lies in its pioneering, innovation-friendly regulatory framework (specifically the DLT Act), a collaborative "Crypto Valley" ecosystem, and a strong integration of digital assets into its traditional financial sector. It was one of the first countries to enact comprehensive legal regulations for Distributed Ledger Technology (DLT) in August 2021. This "DLT Act" created legal certainty for tokenized assets and trading venues, a move that is technology-neutral and attracts global companies. The city of Zug, and the broader Greater Zurich Area, is known as "Crypto Valley," a major global hub for blockchain companies, startups, and foundations, including early movers like the Ethereum Foundation and Bitcoin Suisse. This ecosystem fosters collaboration between business, academia, and the government. Swiss banks and financial institutions, like the SIX Digital Exchange (SDX), have been authorized by the Swiss Financial Market Supervisory Authority (FINMA) to operate the world's first fully regulated, integrated trading, settlement, and custody infrastructure for digital assets.


